AWARD

Postponing the 2019 Julius Shiskin Memorial Award

The Selection Committee for the Julius Shiskin Memorial Award for Economic Statistics, and the Award sponsors, regret to announce that it is necessary to make a one-time postponement of the annual Award. The Award, which is usually announced in mid-May, is sponsored by the Business and Economics Section of the American Statistical Association, the National Association for Business Economics, and the Washington Statistical Society. The Selection Committee now consists of representatives from the Bureau of Economic Analysis, Bureau of Labor Statistics, Census Bureau, Committee on National Statistics, National Bureau of Economic Research, Office of Management and Budget, and the sponsoring organizations.

For 2018, we made two Awards. Although each was less than individual Awards in earlier years, the total was somewhat higher, thereby reducing available funding for 2019. Not having resolved the funding issue, in large part because of health setbacks that affected both the Committee Chair and the Committee Secretary, the Committee did not announce the 2019 nomination process.

The consensus of the Committee has been to postpone making an Award until 2020 and to rollover nominations received for 2019 for consideration at that time.

Over the next few months, the Committee will work with the sponsors to explore how to improve the management of, and increase the available funding for, the Award. The Committee will establish a management structure that obtains financial commitments in a timely fashion and assists in executing the Award process. The Committee also will explore with the organizations represented on it, and the sponsors, increasing their assistance in publicizing and distributing the calls for nominations.

In recent years, the U.S. economy has undergone substantial change and its measurement has called for the use of new source data and methods. Some of these sources are no longer sample surveys, but data from private sources and additional administrative data. The Award needs to cover these changes as well as "nontraditional" economic statistics, such as data on health, education, population, and income distribution.

A newly organized Committee will be well positioned to adapt to these important developments.

Where do you work and what do you do?

I am a PhD Computational Sciences and Informatics Presidential Scholar at the Department of Computational and Data Sciences (CDS) at George Mason University. My research is in image analysis and data science. Specifically, I am working on classifying medical pill shapes. While it would be desirable to have a model be able to identify an unknown pill automatically, this has not been able to be achieved at a practical level. Thus, the research community has decided to build models that identify pill color, text, shape, etc. and then eventually combine all the models to create this system. For the time being, I have decided to focus on building a simple, yet effective, model for understanding and classifying pill shape.

What attracted you to your current position?

After obtaining my MS in Statistical Science at George Mason University, I wanted to earn my PhD while focusing on image data. The CDS department specializes in this area, so it seemed like a natural transition.
